CREDIT AGREEMENT

THE APPLICANT ATTESTS AND AGREES TO THE FOLLOWING:

- The information provided on this credit application is complete and accurate.
- The undersigned warrants and confirms that the information given herein is true and correct and HEREBY PERMITS AND AUTHORIZES Olympic Building Centre to conduct an investigation of the applicants credit history, now and in the future solely at the discretion of Olympic Building Centre, through credit reporting agencies as well as, through references, financial institutions and suppliers given or through sources that Olympic Building Centre considers desirable, with the understanding and agreement that Olympic Building Centre decision to grant or deny credit may be based in whole or in part on the information obtained in this investigation or given herein. As well as allow the storage of this information at Olympic Building Centre.
- The applicant agrees to pay all invoices by the 30th day of the month following receipt of goods and interest will be charged at the rate of 1.5% per month or 19.56% per annum (compounded), calculated and payable monthly, or at such other rate as shall be established by Olympic Building Centre. And specified on the said invoice, statement, price list or quotation from time to time, on all invoiced amounts which are past due for payment both before and after judgment.
- The undersigned hereby agrees that the terms and agreements contained in this Credit Application and Agreement ("The Agreement") shall not merge with the terms and agreements contained in any other agreement entered into between the undersigned, either alone or with others and Olympic Building Centre. The terms and agreements contained in this Agreement may only be waived or modified in writing by Olympic Building Centre, where such writing refers specifically to this Agreement. If a conflict arises between any term or agreement contained in this Agreement and any term or agreement contained in any other agreement, the term or agreement in this Agreement shall prevail, unless this Agreement shall have been previously modified pursuant to this clause.
- Applicant agrees that title to goods ordered does not pass until fully paid for. Applicant grants to Olympic Building Centre a security interest in goods supplied for the unpaid purchase price.
- The undersigned also agrees to and gives permission to Olympic Building Centre to: A) exchange information regarding the credit of the applicant, as well as account performance when requested by other creditors or perspective creditors who have been authorized by the applicant to request such information and to B) allow the storage of this information at Olympic Building Centre.
- The undersigned also agrees that all payments to Olympic Building Centre shall be made to the address shown on Olympic Building Centre invoices and/or statements. - In the event of payment default the applicant:

 2. Agrees to pay the cost of legal and collection fees incurred by Olympic Building Centre for the purpose of collecting the balance owing by the applicant, on a solicitor and own client cost basis.
